**Special Circumstances and/or Special Provision**

If you are making a claim for your child to be considered under Special Circumstances or Special Provision, please read carefully the relevant sections of Dalriada School’s Criteria for Admission to Year 8 in 2025-2026.

**FEES AND CHARGES:** A capital Fee (currently £12 per annum) and a Consolidated Charge (Currently £178) are charged in relation to all pupils.

**Respective functions of the Board of Governors and Principal in relation to Admissions to the school**

The School’s Board of Governors determines Criteria for Admission. The Education Committee of the Board of Governors considers applications to Year 8 and selects pupils for admission in the light of the criteria set out below.

**ADMISSIONS CRITERIA FOR ENTRY INTO YEAR 8**

During the admissions procedure when applying the criteria punctual applications will be considered before late applications are considered. The application procedure opens on 28 January 2025 at noon (GMT) and an application submitted by the closing date of 20 February 2025 at 12 noon (GMT) will be treated as a punctual application. An application received after 12 noon (GMT) on 20 February 2025 and up to 4pm on 25 February 2025 will be treated as a late application.

Dalriada School, as a co-educational grammar school, provides secondary education for girls and boys in the upper band of the range of academic ability. The School draws its pupils from a wide geographical area and from the full range of social, religious and cultural backgrounds.

When considering which children should be selected for admission, the Education Committee of the Board of Governors will only take into account information which is detailed on or attached to the Transfer Application. Parents should therefore ensure that all information pertaining to their child and relevant to the school’s admission criteria is stated on the online transfer application or uploaded onto it.

Please note that it is expected that all those seeking admission to Dalriada School should sit the SEAG Entrance Assessment for admissions in 2025-2026, conducted by the Schools Entrance Assessment Group (hereinafter referred to as SEAG).

Children resident in Northern Ireland, at the time of their proposed admission, will be selected for admission before any other child.

If the number of applications for Year 8 in September 2025 exceeds the number of places available, pupils will be selected for admission according to the following criteria. They are set out in order of priority.

### Criterion 1

Academic ability is indicated only by the result awarded in the SEAG Entrance Assessment. Children will be admitted in rank order according to their total standardised age score result with higher scores preceding lower scores. Please ensure that you provide the score in the SEAG Entrance Assessment test by attaching/uploading an image of the original SEAG Entrance Assessment score notification sheet provided by SEAG to the Online Transfer Application via the EA portal.

Applications for Special Circumstances/Special Provision will be considered by the Education Committee of the Board of Governors. Where it is accepted, the Education Committee will determine, on the basis of the information available, a score for the pupil. The pupil will then be considered with all other pupils who have received an SEAG Entrance Assessment score and the Admissions Criteria applied. In both Special Circumstances and Special Provision, the School will examine other relevant factors, as explained below, in assessing those qualifying candidates. It is important that those seeking such qualifications make sure that the relevant material and evidence is submitted, setting out clearly why the criteria for this consideration should be applicable.

#### (a) Special Circumstances

An exception may be made where there is documentary evidence that a child's overall SEAG Entrance Assessment result may have been adversely affected by medical or other problems.

Parents who wish to claim Special Circumstances should:-

- (i) read carefully Dalriada School's Admissions Criteria. The Education Committee of the Board of Governors will consider claims and decide on the validity of each case.
- (ii) Download and complete Form SC from the Dalriada School website and upload on to the EA portal along with supporting evidence. To validate the claim it is essential that all evidence is documented and provided at the time of application
  - where the problem is a medical one, the school will require the production of evidence that the pupil was examined by a medical practitioner in relation to the illness at the time of the assessment.
  - where the problem is of a non-medical nature, appropriate evidence should be provided.
  - objective documentary educational evidence must be provided. This should include, where they exist, the results for the pupil of any standardised test conducted in Year 5, Year 6 and Year 7 and the results in any end of year tests in English and Maths and any other appropriate test results.

**It is essential that all evidence is documented and provided at the time of application**

#### (b) Special Provision

If the child has not taken the SEAG Entrance Assessment for one of the reasons below, other evidence of academic ability and aptitude will be considered in deciding whether the applicant should be admitted:

- (i) transfer from a school outside Northern Ireland after the closing date to register to sit the SEAG Assessment.
- (ii) more than half of primary education received outside Northern Ireland.
- (iii) a child was entered for the SEAG Entrance Assessment and, because of unforeseen and serious medical or other problems was unable to sit the SEAG Entrance Assessment or had an estimated outcome because they only sat one of the two Entrance Assessment papers.
- (iv) for exceptional reasons, a child was not registered to sit the SEAG Entrance Assessment.

Parents who wish to claim Special Provision should contact Dalriada School as soon as possible and must

- read carefully the requirements set out in Dalriada School's admissions criteria. The Education Committee of the Board of Governors will consider claims and decide on the validity of each case.
- download and complete Form SP from Dalriada School website and upload onto the EA portal along with supporting evidence required to validate the claim. **It is essential that all evidence is documented and provided at the time of application.**
- all special provision applicants must undergo a psychometric assessment administered by Dalriada School.

The Board of Governors reserves the right to require such supplementary evidence as it may determine to support or verify information on any applicant's transfer application.

Where it is necessary to distinguish between children who have been awarded the same score in the SEAG Entrance Assessment the criteria 2-5 will be used.

**Criterion 2** Children who, at the date of their application, are members of a family with a child currently enrolled at Dalriada School.

**Criterion 3** Children whose family previously had a child enrolled at Dalriada School.

**Criterion 4** Children who, at the date of their application are the eldest child (including twins and other multiples) of the family eligible to apply for admission to Dalriada School.

**Criterion 5** The age of the child, preference being given to an older child.

**NOTE:** The criteria above will be applied to applications for admission to Year 8 throughout the 2025-2026 school year.

### **ADMISSIONS TO YEAR 8 AFTER 1 SEPTEMBER 2025**

Parents who wish to have their child considered for admission in the event of a place arising after 1 September 2025 should write to the Principal clearly stating this. Should a vacancy arise, the above criteria will be applied to select pupils from our waiting list.

**Applicants may be required to provide original documentation verifying their home address.**
